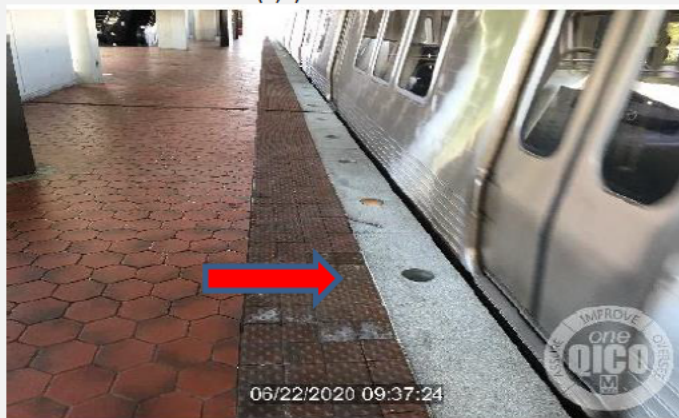

Risk – Elevated (4,3) – LVEM



- 6. Platform edges uneven (Platform, Track 1 and Track 2, multiple locations)
Risk – Moderate (3,3) – PLNT




- 7. Emergency Trip Station (ETS) D122 blue light is out (Platform Track 2 north end, adjacent to Room 112)
Risk – Elevated (4,3) – LVEM
