All elevators and escalators are working and in service, all tools, equipment and trash has been removed, the Fire Alarm System in operational, and the platform is of all tools and equipment. There was one ADA defect noted on the rail station inspection checklist. The bathrooms at Arlington Cemetery Station will not be functional for the Station reopening. WMATA will keep the ADA compliant Porta-Johns that are located by to Station entrance until the bathrooms are complete.
